Example calculation of price below 1000 kWh used :  
 10.0 cents per kWh X 500 kWh used = \$50.00  
 \$50.00 + \$10.00 Monthly Meter Fee = \$60.00  
 \$60.00 ÷ 500 kWh used = 12.0 cents per kWh
